

**PROCEEDINGS OF THE 7<sup>TH</sup> EXECUTIVE COMMITTEE (EC) MEETING OF  
JHARKHAND SPACE APPLICATIONS CENTER (JSAC) HELD IN THE  
OFFICE OF DEVELOPMENT COMMISSIONER, NEPAL HOUSE, RANCHI ON  
31<sup>st</sup> October, 2006 AT 15:30 HRS.**

1. The 7th meeting of the Executive Committee of the Jharkhand Space Applications Center (JSAC) was held in the office of the Development Commissioner, Govt. of Jharkhand on 31st October, 2006 from 15:30 hours.
2. The list of members, who attended the meeting, is annexed.
3. The Executive Committee (EC) confirmed the proceedings of the 6th meeting and took note of the Action Taken Report put up before it. While approving the minutes, the EC also decided as under:-
  - Rules, Regulations & Service conditions including delegation of powers must be revised at the earliest and the same may be presented in the next EC meeting for discussion and approval.
  - Funds available with JSAC should be put in flexible savings account to take advantage of the flexi savings scheme" both with regard to drawal of funds as per requirement as well as higher returns on account of interest.
  - The Committee approved and recommended fixation of pay in respect of Dr. A. P. Subudhi, currently incumbent to the post of Director, JSAC with immediate effect in the scale of Rs. 18400-22400/- and decided to pursue the same with the Finance Department for Government approval.
  - Chief ~~Secretary, Government of Jharkhand be requested to fix the date for the long~~ ~~overdue meeting of the Governing Body of JSAC.~~
4. Executive Committee approved to introduce EPF scheme for the employees of JSAC as required under law *after consulting the law Dept. till 15 Sept.*


