

**PROCEEDINGS OF THE 6TH EXECUTIVE COMMITTEE (EC) MEETING OF
JHARKHAND SPACE APPLICATIONS CENTER (JSAC) HELD IN THE
OFFICE OF DEVELOPMENT COMMISSIONER, NEPAL HOUSE, RANCHI ON
11TH MAY, 2006 AT 10.00 HRS.**

A meeting of the Executive Committee members of Jharkhand Space Applications Center (JSAC) was held in the office of Development Commissioner, Nepal House, Ranchi on 11th May, 2006 at 10.00 Hrs.

1. Shri T. Nandakumar, Development Commissioner, Govt. of Jharkhand and Executive Chairman, EC/JSAC welcomed the members of the Executive Committee and initiated the proceedings. Shri R.S.Sharma, Principal Secretary, IT, Govt. of Jharkhand and Executive Vice-Chairman, EC/JSAC briefed the Committee about the activities and issues of Jharkhand Space Applications Center.
2. Shri R. S. Sharma, Vice-Chairman, EC/JSAC and Dr. A. P. Subudhi, Member-Secretary, EC/JSAC briefed the Committee regarding action taken report of the 5th EC meeting. Executive Committee confirmed and approved the proceedings of the action taken report of the previous EC meeting. Further, the Executive Committee noted the following action to be taken at the earliest.

- Financial status and audited accounts of JSAC for the year 2005-06 must be completed soon and the same must be presented in the next EC meeting for discussion.

- The Executive Committee emphasized that the GIS database created so far must be hosted in the Jharkhand Government Web Portal.
- Action should be initiated for filling the reserved vacant posts.
- Rules, Regulation & Service condition of JSAC must be prepared at the earliest and the same may be presented in next EC meeting for discussion and approval.

3. Shri R. S. Sharma, Principal Secretary, IT and Dr. A. P. Subudhi, Director, JSAC briefed the Committee about various projects being implemented by JSAC. However, Development Commissioner emphasized that a separate EC meeting should be called to discuss in detail the status of project activities being implemented by JSAC. If possible user departments should also be called as special invitee to find out utility and implementation of these projects.

Development Commissioner also suggested that village level database must be created for entire Jharkhand State on the line of Village Information System-Namkum pilot block. He suggested to prepare a detailed project estimate for implementing this project for entire Jharkhand State. Shri R. S. Sharma briefed the Committee that JSAC had already created some information covering Jharkhand State. Some more themes to be created for entire state in phases.

Development Commissioner emphasized that JSAC should indicate the type of database to be created and prioritize the process for data creation so that there is no duplication. Dr. Subudhi, Director, JSAC was asked to prepare the status of creation of various thematic layers and also prepare a document for future action. Shri Nandakumar also suggested to interact with DVC for database creation and mapping for watershed developments.

4. Dr. Subudhi briefed the Committee about Implementation of project and delegation of powers. Shri Mukhtiar Singh, Principal Secretary, Finance Department suggested that delegation of powers of Director, JSAC should be re-submitted for discussion and approval after incorporating the earlier delegation of powers with proposed items showing reasons for approval by Executive Committee.

The powers of the Executive Committee of JSAC may be exercised by Sri R. S. Sharma, Principal Secretary, IT beyond the delegation powers of Director, JSAC for day to day functioning as well as implementation of projects till the finalization and approval of Rules, Regulations and Service conditions of JSAC as well as delegation power of Director, JSAC, which should be done within a period of six months.

8. Mr. R. S. Sharma informed the Executive Committee about increasing activities of Jharkhand Space Applications Center. He emphasized the need of recruiting few more new technical staff for JSAC. Accordingly, the Executive Committee approved to create following new technical staff for JSAC.
